**SUBJECT: SEVERE REVENUE DROP TRIGGERS NEED TO SAVE MORE**

We know you have all been working diligently to implement the variety of spending controls that were imposed in August and October. Your effective work to save money in these difficult times has already paid off, but ever-deepening national economic problems and historically low consumer confidence have caused a sharp drop in revenue. The forecasted drop for Fiscal Year 2009 alone is \$503 million – which will leave a negative balance by the end of the fiscal year if left unaddressed.

A revenue drop this steep requires an immediate, firm and direct response to capture \$260 million in additional cuts and savings that can be incorporated into the Governor's 2009 Supplemental Budget now being developed. You should aim to cut or save from your remaining FY 2009 General Fund appropriations as indicated on the attached list. I want to clarify that this is in addition to cuts you made in August and October.

We need you to use the following criteria to identify these cuts and savings:

1. Identify and take under-expenditures and efficiencies that go beyond those already taken;
2. Continue to pull back on new programs not yet fully implemented; and
3. Scale back existing programs and activities that fall lower in the Priorities of Government process and/or have been identified in your work with OFM as 2009-11 Biennial Budget reduction items. Please consult with your OFM budget analyst and seek appropriate legal advice as appropriate when taking these steps.

All of this work must be incorporated into the 2009 Supplemental Budget, and where appropriate, also will be included in the 2009-11 Biennial Budget. Be sure your OFM analyst has received your input by Monday, December 1.

Thank you again for all of your efforts during these challenging economic times.
